FISHERY GOVERNANCE AND COST OF ENFORCEMENT

Alghero, Italy, 23rd to 24th June 2008

The European Association of Fisheries Economists (EAFE) presents a conference on “*fishery governance and cost of enforcement*”. The conference will be held in Alghero and is co-organised with the University of Sassari and IREPA Onlus, from Monday 23 to Tuesday 24 June 2008.

The conference is intended to provide a forum for discussion and evaluation of different types of enforcement required by different fisheries management systems and for analysis of the enforcement costs necessary to achieve a given level of compliance. The conference also aims to contribute to the ongoing discussion within the review of the control regulation by the European Commission.

The specific sessions of the conference are:

1. Governance, Control & Enforcement

- Comparison of different management systems and different enforcement and control schemes
- Alternative approaches to enforcement: co-management, self-management
- The cost of non-compliance in different fisheries management regimes

2. Costs & Benefits of control and enforcement

- Enforcement of fisheries regulations and its costs and benefits in particular fisheries, case studies
- Empirical models to test the economic impact of enforcement effort and enforcement tools
- The present EU Control Regulation and future developments
